US Mail, e-mail, FAX, phone call, or the best means of all....a personal visit! It is really a great experience to meet our elected Congressman face to face. They are very gracious and just want to know your position on legislation. Everyone should try it...at least once. Think what an impact we could make if even 10% of our 400 chapter members scheduled an appointment with "Doc" Hastings. 40 people would make an impression on him. The May 15<sup>th</sup> deadline for MEDICARE Part D, the prescription benefit, is fast approaching. If you don't have comparable coverage in your health care policy, you should consider this supplement. If you apply after this deadline, you may have a delay in coverage as well as be charged a penalty. Stay informed! Read your NARFE Magazine- Retirement Life. Check the NARFE web-site. And don't be afraid to stand up with your fellow-NARFE'rs. We need to be the "squeaking wheel"...to get the "grease". Communicate with your Representative or your Senators. We are in a congressional election year. The politicians are now looking for ways to reduce the obscene deficits created through tax cuts and increased spending.

**NARFE-PAC** (Continued) Fortunately entitlement programs (including federal retirement) were not directly cut in the FY2007 budget resolution passed by the Senate in March. The House is more likely to propose entitlement reductions when it considers its version of the budget resolution. Last September, the House Republican Study Committee (RSC) proposed to reduce the retirement annuities of federal workers and to require many of them to pay a larger share of their health insurance premiums. The RSC also repeated its cost shifting plan on health insurance premiums in its Contract with America Renewed, a budget options paper released on March 8.

If we are going to maintain our earned benefits, it is important to get one three zero two turned on to the process and support candidates that are willing to support our interests. As an organization, we can help do this through NARFE-PAC. If we don't get involved, the politicians may turn on us and try to balance the budget on our backs through benefit reductions. Sometimes you have to keep running just to stay in the same place.

Please contribute what you can afford to NARFE-PAC, and keep after the politicians and let them know your feelings on our key issues.
