President: Don Binder.

- Region IX VP Lanny Ross has announced he will not run for re-election at this year's NARFE National Convention, a change from his previous announcement.
- Future of NARFE (FON) report:
 - Don provided a general overview and the board had a preliminary discussion. He'll briefly mention this at the chapter meeting.
 - The NARFE Executive Board voted to reduce the number of regions from 10 to 5. Our region goes from 5 states to 9 plus Guam and the Republic of the Phillippines. With concern for the size, the chapter board moved and approved Don exploring submitting a bylaws amendment resolution for the August National Convention that would reverse this decision at least for the next 2 years.
 - Delegates at the National Convention will be voting on aspects of the FON plan.
- 2014 WSFC Convention, May 13-15, Silverdale Beach Hotel, Silverdale, Washington.
 - Mary has submitted the list of delegate names. Some are still projected; Mary will amend, if needed. [Note: The chapter has 11 delegates and 2 at-large delegates.]
 - o The board had no resolutions they want to submit.
 - Nancy reported there will be a caucus at the convention to elect DVPs. For District V, to date, she is the only candidate.
- PROTECT America's Heartbeat Don updated the board on the M+R reports, which highlight
 contractor activities, initiatives, etc. Don said he would be discussing further with Lanny Ross the
 contractor's activities, especially in light of the FON report.
- Backups for positions; training for replacements this remains an ongoing initiative. Pam is a backup for Bill; Don a backup for Steve. Don and Nancy will be meeting with Johanna after the meeting to discuss a membership committee and backup for her membership chairman position.

1st Vice President/Special Programs/Service Office: Lorie Bennett.

- Service Office is nice and tidy. Nancy said there are bags with outdated material for recycling.
- Johanna said she'd make more labels for the extra NARFE magazines used for recruiting.

2nd Vice President: Larry Williams. No report.

<u>Secretary/Sunshine/Newsletter/Public Relations</u>: Mary Binder

- May/June newsletter articles are due to Mary by Friday, April 4. Johanna asked if the names of the
 recently recognized chapter NARFE "distinguished" members could be listed. Mary suggested an
 option to listing the names mentioning that those eligible were recently sent a letter from President
 Don with a NARFE certificate and pin, and anyone not receiving this who believes they meet the criteria
 should contact Johanna. The board concurred with this approach.

- Senior Life Show June 12, Three Rivers Convention Center. Mary said the booth space is reserved.
 Nancy and Lorie volunteered to coordinate staffing the booth. Sig has also volunteered to help, if needed
- Senior Times Expo, April 22, Red Lion Hotel, Pasco Mary reported that the booth fee is \$375; no break for non profits. She said she'd discuss that with the new event coordinators at the *Tri-Cities Area Journal of Business*. Nancy said she was planning to attend and will provide feedback on the event at the next board meeting. May be an option for a chapter booth in 2015.
- Sunshine former member Edith Stoltz passed away recently. Without an address, Johanna recommended just listing her name in the next newsletter as there are members who knew her. Mary suggested that she could contact both the funeral home taking care of the burial arrangements and the nursing home where Edith had been asking if she could send a condolence card to the family in care of them and have them pass it to the family. Johanna also mentioned having chapter service office cards at local funeral homes; she said this is something the chapter used to do. Lorie said she'd follow up.
