NARFE CHAPTER 1192 VIRTUAL EXECUTIVE BOARD MEETING MINUTES September 26, 2022, 10:00 a.m., Virtual

<u>Call to Order</u>: President Pat Turner called the virtual meeting to order at 10:00 a.m. She reminded members to silence their phones and led the Pledge of Allegiance.

<u>Attendance</u>: Members present besides President Pat: Mary Binder; Liz Bowers; Johanna Caylor; Nancy Crosby; Faye Vlieger; Darleen Wall; John Wetterling; Larry Williams. Absent: Lorie Bennett; Randy Grekowicz; Ellen LeVee. There were no visitors, only board members.

Officer and Coordinator Reports

President: Pat Turner

- Pat said her main focus for this board meeting was looking for ways to shorten chapter meetings as "they are too long."
- Regarding shortening chapter meetings, Pat led the board in a discussion to gather comments, ideas and suggestions. Highlights follow:
 - Have meeting programs after the business meeting, whenever possible.
 - o If a speaker has AV needs, have those set up during social time, 11:30 to noon.
 - Offer lunch as an option to speakers, e.g., if they do their presentation at the end of the business meeting and do not have AV needs, they may not want to arrive until just prior to their presentation so would not need/want lunch.
 - o Pat said she would like "30/30," that is a 30-minute meeting and 30-minute program, including the presentation and Qs/As.
 - Members seem very interested in the information Service Officer Ellen provides.
 - There was a comment that Mary provides too much detail, but also noted that she covers several areas for which she has responsibility both at the chapter and state levels. Mary said she would review her areas, looking for ways to shorten her info.
 - Faye offered that she could give her "Sunshine" report to Pat for Pat to report. This
 could save time switching between speakers. Maybe others could do the same.
 - Pat suggested to John that he might be able to give PAC summary information, that is, more of a one-liner approach vs. more details as people tend to get lost when a lot of figures are read to them.
 - Pat asked everyone to review their areas.
 - Nancy reminded members that in the chapter's Red Lion contract, the time frame for the chapter having the room is 10:00 a.m. to 1:00 p.m. So far, Nancy has not received a complaint from the Red Lion about the chapter using the room past 1 p.m.
- Johanna asked about having meeting announcements in *The Tri-City Herald* as we did in the past. Mary shared that the paper is no longer running these type public service announcements. However, there may be a possibility in the *Tri-Cities Area Journal of Business* and its *Senior Times* publication. Pat asked Johanna if she was volunteering to take on this responsibility.
- Getting members interested in/volunteering for officer and committee coordinator positions remains a top priority, including a focus on trying to mentor such members.

Vice President/Hospitality: Nancy Crosby - Nothing to report.

- 2022 chapter budget Liz said, "Yes, we have money; yes, the bills have been paid."
- Liz confirmed that Jeff Peterson was scheduled to again provide a holiday music program at the chapter's December meeting. She then led a discussion on whether to keep his stipend at \$125 or to increase it to \$150. After a brief discussion, there was a motion and second to increase the amount to \$150. The increase received unanimous support.

- VP Mary:
 - The WSF virtual annual meeting/conference is scheduled for October 11-13.
 - There is a draft agenda; input is still welcomed.
 - Voting in the WSF elections would remain open through October 10 for the 4 officer positions president; vice president; secretary; treasurer. Cray Henry, a national-only member and retired director, DoD High Performance Computing Modernization Program, volunteered to run for president; Mary Traxler, a member of Olympia Timberland/South Sound Chapter 236, volunteered to run for vice president; and both Secretary Linda Wallers and Treasurer Arlene Patton agreed to run again for their respective positions. The federation's 3 district vice presidents will be elected during the conference's respective district caucuses. Both Mary Binder, District I VP, and Bea Bull, District III VP, have volunteered to run again for their respective positions. Verna Wright has volunteered to run for the District II VP, which has been vacant since the passing of John Wells earlier this year.

Legislative Coordinator: *Mary Binder*

- National legislation:
 - Repealing GPO and WEP remains a top legislative priority for the NARFE Advocacy Department. H.R. 82, Social Security Fairness Act now has enough co-sponsors to bring the legislation to a vote on the House floor. NARFE continues to encourage members to contact their legislators and ask for a floor vote.
 - COLA details for 2023 are scheduled to be released Thursday, October 13.
- State legislation:
 - The Chamber-sponsored annual elected leaders reception is scheduled for September 29, 4 to 6 p.m., The Reach Museum. Mary said she is planning to attend.
 - o The state legislature is scheduled to meet for its 2023 session beginning January 9.
 - Washington Policy Center events:
 - Friday, September 16, Davenport Grand, Spokane, annual Eastern Washington WPC dinner. Guest speakers were Tulsi Gabbard, former Democratic congresswoman, and Victor David Hanson, a historian. Mary attended and provided a brief recap.

- Larry reported that he had \$85 in NARFE Alzheimer's Research Fund donations to submit to WSF Alzheimer's Coordinator Lorie Bennett for forwarding to the Alzheimer's Association.
- The area's annual Walk to End Alzheimer's is Sunday, October 9. Larry reported that 6 members have joined the chapter team and that there are \$420 in donations.
