Chapter President – Nancy Crosby

Happy New Year! I hope 2010 brings you all health, happiness and a raise in your annuity!!!! Looking ahead, I encourage you to attend our Chapter meetings as we are planning interesting programs that will speak to issues affecting us all. For the Chapter's January meeting, our guest speaker will be Dr. Travis Carter, a local podiatrist, who will talk about foot care for seniors. Our February meeting will have a representative from Sunset Gardens provide us planning options.

NARFE President Margaret Baptiste sent a message December 9 with the results on the recent NARFE Dues Referendum vote. She said, "Our members have spoken: 65.41 percent voted for, and 34.59 percent voted against. Having failed to receive the necessary two-thirds majority of votes cast, the referendum was defeated. We mailed 1,508 ballots to our chapters and delegates-at-large ... of this total ... 224 ballots were invalid (wrong number of votes, no signatures, etc.), and 256 ballots were not returned. We will post this in the February issue of NARFE magazine." The referendum may have passed if 224 of the chapters that voted would have filled in the ballot correctly. We are fortunate to have officers who are aware of the requirements and our votes were accepted.

I hope all of you who have Internet access have signed up to receive the **NARFE Global Email Messaging System (GEMS)**. In December we received a hotline request to contact our Federal elected representatives to ask them to protect our FEHBP benefits. There was a concern that we could be in a larger pool of recipients, but due to NARFE lobbying the Senate passed an amendment that states: "Premiums of FEHBP and the proposed OPM-administered multi-state plans would be calculated in separate risk pools." I encourage you to stay on top of the issues and be aware of the impacts they may have on our earned benefits. Check our web site for updates.

I also encourage you to consider becoming involved in a chapter committee and/or our Washington State Federation of Chapters. We already have Carl Gallion as District V vice president, Don Binder as Federation NARFE-PAC chairman and I am the Federation Nominating Committee chairman. We will be soliciting applicants for the various Federation offices; voting will be at the May state convention.

Finally, Anne Ross our Sunshine Committee chairman for many years resigned. Anne, thank you for your thoughtful dedication to this committee. We have very much appreciated your efforts and your "sunshine" personality! And, thank you, Carolyn Reeploeg, for volunteering to serve as the Chapter's new sunshine chair.

District V Vice President – Carl Gallion

Ever needed a reason to thank NARFE? Well, to the credit of our 2008 WSFC convention in Walla Walla, we passed a resolution supporting legislation that would give credit for unused sick leave to retiring FERS employees. That resolution was later adopted at NARFE's national convention and became part of its national platform. Because of the fine efforts of NARFE's legislative team, not only did legislation get written but was passed by Congress AND on OCTOBER 28, President Obama signed it into law. It was the right thing to do ... equality for FERS employees. This is a great example of a "grassroots" initiative. It started with a discussion at a local health fair, and was ultimately acted upon at all levels of NARFE. I am proud to have been the author and defender of this resolution.

Use this initiative and its results as an example to FERS employees of why they need NARFE ... perhaps even more than those already retired. Legislative – Don and Mary Binder

Medicare Part B premium increase likely – As you are already aware, retirees will receive no increase in benefits for 2010. However, for those who retired under CSRS and elected to be covered under Medicare Part B, unless Congress acts very soon, there will be an increase in premiums from \$96 per month to \$110 or more per month. Congress is considering legislation to mitigate this action for one year. Senator Tom Coburn, R-OK, the person doing the most to prevent action in the Senate, made the following statement on the Senate floor in October "We are going to take \$2.8 billion from our kids or from future Medicare payments – one way or the other, we are going to steal it from our kids – to fix a problem for 5 percent of the people who are on Medicare or will be on Medicare." To make matters worse, it's not only Republicans who agreed with him. House Majority Leader Steny Hoyer, D-Md., also opposed the bill, likening it to freezing billionaire Ross Perot's Medicare premiums. However, NARFE's National legislative office sees this as a matter of fairness.

"Government employees who do not receive Social Security are being singled out, and are subsidizing the cost of others," said NARFE legislative director Daniel Adcock.

Adcock said he still was hopeful that something could be done so that at least half the 2010 premiums could be altered, but noted there's little indication the Senate will pass the bill anytime soon. At the very least, it will be delayed until after senators vote on the massive health care reform bill. Adcock said if the Senate doesn't pass the bill by the end of 2009, it might have to go back to the House, stalling it even further.

Health Benefits – As this newsletter goes to press, the information and possible action changes daily. Therefore, if both houses of

Congress have not finalized debate and sent a bill to the President for signature regarding the National Health Insurance program 1617 by the time you are reading this newsletter, we suggest you check the following web sites for information: NARFE HQ, www.narfe.org; Washington State Federation of Chapters www.narfewa.net; and Chapter 1192 www.narfe1192.org.

We will be prepared to discuss this issue at the January and, if necessary, February meetings. Remember, as taxpayers this legislation WILL impact on each of us.
