## Legislative – Don and Mary Binder

As most of you know Washington State is getting a 10th U.S. Congressional District based on population growth determined by the 2010 national census. Additionally, there must be a redistribution of the state's other 9 districts, and all state house and senate districts. In 1983, Washington State voters established the Washington State Redistricting Commission to ensure boundaries are redrawn through a fair and bipartisan process. The Commission has 2 Democrats and 2 Republicans as voting members and 1 non-voting, nonpartisan chair, who for this Commission, is from Richland.

The Commission continues to work its will, but only until January 1. After that, decisions are moved from them to our State Supreme Court. For the U.S. House of Representatives, all the options on the table have us remaining in Congressman "Doc" Hastings' district. So, while other locations on the state's east side will see a shift, we will almost assuredly not.

At newsletter press time, the Commission continues to meet in subcommittees and as a whole, but to date, has not reached a resolution. When we know the final districts, we will advise all members we can contact via e-mail, and post information on our web-site (**Note: If we do not have your e-mail address, please send it to Johanna Caylor, membership chairman and/or Nancy Crosby, treasurer. We will use it only for NARFE business.**)

Finally, we continue to work with our Region IX VP Lanny Ross, Federation President Sandy Cagle, and others in the Federation and at NARFE headquarters to ensure we are aware of the latest issues that will impact on NARFE members — current federal employees, retirees and survivors. But as always, let us know if you have 7614 questions!
