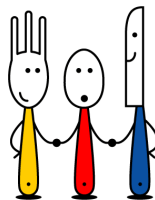
## 2nd VP/Service Officer – John Cavanaugh

## WSF President – Nancy Crosby

The Washington State Federation (WSF) board met Thursday, December 6, at the Tacoma La Quinta Hotel. Chapter 1192 members Mary Binder and Lorie Bennett also attended in their respective roles as the WSF VP and WSF Alzheimer's chairman. Bea Bull from Bremerton Chapter 181 was installed as the District IV VP, replacing Al Costa who moved out of state.

The 2019 WSF budget was presented, discussed and approved by the board. Highlights include using the 10-percent dues money we receive from NARFE to help promote attendance at conferences and training opportunities. Also, the \$1.20 per member "per capita tax" that chapters have provided the federation each year is waived for 2019 to encourage chapters to use the money to recruit and retain members and/or attend conferences and workshops.



Besides the closure of the Walla Walla chapter in 2018, several other federation chapters are on "life support." Nationally, NARFE has closed 274 chapters since November 2017; and, as of October 31, NARFE membership had dropped to 201,773. Our WSF had 5,813 members as of the same date – 3,179 chapter and 2,634 national members. So, recruiting and retaining members remains critical to NARFE's future.

A reminder! Our 5-state, 2019 Region IX Training Conference will be Friday and Saturday, May 17-18, Three Rivers Convention Center, Kennewick. Besides an opportunity to meet other Region IX members, the 5 federation presidents – Alaska, Idaho, Montana, Oregon and Washington – are planning an informative conference. The WSF board approved a \$50 "scholarship" for each WSF member in good standing to attend the conference. As this event is local, I hope you plan to attend. No long-distance traveling and no overnight stays. A win-win!



The next WSF board meeting will be Wednesday, April 10, again in Tacoma at the La Quinta Hotel.

However, our WSF board approved a \$250 “scholarship” to help offset costs for members in good standing who attend.
