## Vice President – Nancy Crosby

I recently met with the catering manager, Red Lion Hotel Kennewick Columbia Center to discuss the chapter's 2022 group sales agreement. There is an increase from \$19.71 to \$21.02 person. Members have been paying \$20 per person (rounded up from \$19.71) and even though there is a price increase, the chapter board voted to keep the lunch charge to members at the \$20 rate for 2022. The chapter will make up the \$1.02 difference from non-dues funds.

However, we are contractually required to cover the cost for 15 lunches at each meeting as a guarantee. That is why it is SO IMPORTANT that members attend chapter meetings AND order lunch. The menu is close to the same as in 2021 with just a few exceptions. The meals include salad, entrée and dessert. For those needing special meals, the hotel can accommodate the requests. The menus and meeting programs are posted on the chapter website and are published in the newsletter. (See page 1.)



It has been SO WONDERFUL to hold our fall meetings in person and we are SO FORTUNATE to have a location that provides room set up, a microphone and speakers, flags and a visual-aid cart for presentations at no extra cost to the chapter! In the past, other venues we have looked at charge extra for these items.

Now that the new year is here, there are several things you should consider and possibly do, if applicable.

- ♦ Medicare Reimbursement from some FEHB plans. When you receive your Social Security statement or other confirmation you have Medicare Part B, you can file with your FEHB plan and start receiving the reimbursement vs. waiting until the end of the year.
- ♦ Designation of Beneficiaries. This is a good time of year to review your beneficiary information for TSP and life insurance, for example, and to ensure correct addresses are listed.

- ♦ NARFE F-100, *Be Prepared for Life's Events, What Your Survivor's Should Know* (09/21), or a similar document. Do you have one in place? Now is a great time to complete or update the document!

For many, MANY years, NARFE's advocacy team and NARFE members have been "advocating" our elected representatives for the repeal of the Windfall Elimination Provision, and also the Government Pension Offset (GPO) – 2 laws that affect millions of local, state and federal retirees.

With now 4 "active bills" on WEP in Congress, you "may be wondering how to focus your efforts." The November NARFE Voices, NARFE's grassroots newsletter, provides excellent details on the 4 bills and recommendations on where to focus our advocacy efforts. **NARFE-PAC – John Wetterling** Several things to highlight. First, the 4th quarter reports should be released around mid-January. I am targeting providing an update at the February chapter meeting.



Next, in years with "mid-term elections," such as 2022, NARFE typically increases PAC disbursements to incumbents and candidates who support NARFE's legislative agenda. How are decisions made? The March 2021 NARFE Magazine highlights the process:

- ♦ NARFE uses a consultative process, that is, decisions are made by the NARFE-PAC Board – the 2 elected national officers and NARFE's staff vice president, policy and programs;
- ♦ For incumbents, voting records and influence are considered; for candidates, their written answers to questions on required paperwork are reviewed;
- ♦ The race's competitiveness is considered;
- ♦ Federation input is considered, including from chapter NARFE-PAC coordinators, along with the amount and quality of communication with the candidate and accessibility to NARFE members.

To note! Party affiliation is not a factor. As a reminder, NARFE is political but is not partisan.

Lastly, something NEW! For NARFE-PAC "sustainers," or those considering becoming one, rather than using a credit card for the monthly automatic donation, sustainers now have "annuity withholding." Advantages? No worries about credit card expiration dates, and "... contributions go further" as there are no credit card fees." Instructions for becoming a sustainer, or making the annuity withholding change, are on the NARFE website. Questions?
