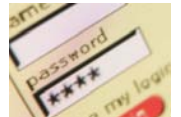

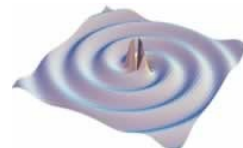

NARFE recently reported that some members who contributed have been solicited by other Alzheimer's organizations. Per NARFE's Alzheimer's Association contract, members should not be solicited. Examples of organizations soliciting are: Alzheimer's Disease Research, Clarksburg, Md., and the Cleveland Clinic Foundation for Alzheimer's Disease, Albert-Lea, Minn. Such groups are not with the Alzheimer's Association in Chicago and contributions will not be credited to NARFE.

Another problem – some acknowledgements from the Alzheimer's Association have included a coupon asking that donations be sent to the Alzheimer's Association, Washington, D.C. These coupons make no mention of NARFE and thus donations made by NARFE members would not be counted toward NARFE's funding goal.
