NARFE is critical – to us who are members and to all other federal employees, retirees and annuitants! So, why do not more people join us? It is perplexing! Ponder the following.

First. NARFE is the only association solely dedicated to preserving and improving the health care and retirement benefits of federal workers and retirees. It is NOT a union, although at the headquarters level NARFE works with unions regarding earned benefits. Today, NARFE's efforts are more important than ever as Congress and the Administration consider unprecedented cuts in federal pay and benefits. As in the past, 3023 NARFE is leading the fight.

Second, "through NARFE-PAC you help elect (and re-elect) legislators who recognize the value of civil service, who understand the importance of recruiting and retaining the best and the brightest, and who support paying federal employees a fair day's pay for a full day's work - including reasonable health and retirement benefits." (NARFE, March 2012, Christopher Farrell and John Hatton article, page 18.) Only NARFE members may contribute; therefore, to grow the pool of potential contributors, we need more members.

Third, receiving the NARFE magazine. It has everything from up-to-date articles on legislative issues important to constituents, to the Q&A sections that provide information about issues covering all aspects of federal employee, retiree and spouse benefits. Two other publications that also help provide members important information. both available electronically, are the Washington Federation's quarterly Federation Reporter, www.narfewa.net, and our own Chapter's bimonthly newsletter www.narfe1192. Finally, we work to have a broad range of speakers at our 10 monthly meetings to again provide our members with key information about national, state and local issues, and other topics of interest to them.

Yes, thoughts to ponder regarding why to join NARFE. Yes, there is strength in numbers! Yes, I believe each of us has an obligation to explain NARFE to our friends and co-workers/ former co-workers and to strongly encourage them to join. The recently passed bill extending the payroll tax cut has been partly funded by 9223 changing retirement contributions for all entering the federal workforce in 2013. The change would also have affected current employees if it weren't for Maryland's Senator Ben Cardin and Rep. Chris Van Hollen. Both are friends of NARFE and would not compromise on impacting current employees; but, the bill is the start of another round of attempts to impact the federal workforce and retirees. Remember federal employees have not had a pay raise in 2 years, giving back to the treasury around \$60M in lost wages while others gave NOTHING! So, continue to stay on top of issues as the next ones could impact you!
