The audit of the chapter's 2017 financial records was conducted in January. All records were in order. A special thank you to Nancy Crosby, our chapter's treasurer for many years, for her accurate recordkeeping.

On a separate note, I came across an FDA press release recently that I think is important. The FDA has "...permitted marketing of the first blood test to evaluate mild traumatic brain injury (mTBI), commonly referred to as concussion, in adults. The TDA reviewed and authorized for marketing the Banyan Brain Trauma Indicator in fewer than 6 months as part of its Break-through Devices Program."

### Legislative - Mary Binder

In case you missed it, the February *narfe* magazine has a summary of NARFE's legislative accomplishments in the 115th Congress as of 2017. For more details, see pages 10-11.

The accomplishments are highlighted in 3 groups. First, NARFE "thwarted ALL attempts by

Congress to cut the earned pay and benefits of federal employees and retirees." Next, NARFE "protected postal retirees' health benefits through the FEHB Program. And third, NARFE

"helped provide more flexible withdrawal options for TSP participants, giving them more control over their own retirement savings."

Looking to 2018, remember the "NARFE Bill Tracker" in each *narfe* edition. This is "your monthly guide to the congressional legislation that NARFE is following." Each issue provides updates. <u>3699</u>

An example of one such issue involves how COLAs are calculated. H.R. 1251, CPI-E Act of 2017 "requires Social Security and many federal retirement programs to use the Consumer Price Index for the elderly (CPI-E) to calculate COLAs to retirement benefits." Again, this is just one example of legislation NARFE is "tracking."

For those who missed the February chapter meeting, Jason Mercier, director, Center for Government Reform, Washington Policy Center, provided members another excellent update on actions in Olympia. He covered everything from the governor's proposed carbon tax, to proposed legislation involving an income tax and capital gains tax to an update on funding education mandated by the state supreme court in its McCleary decision.

Regarding Jason's update, one member told him that he takes "complex issues and makes them understandable" and that he "wouldn't miss his presentation for anything." So, with this positive feedback, Jason has agreed to provide another update at our February 2019 chapter meeting!

### NARFE-PAC - Bob Stewart

The 4th quarter PAC reports, which provide summary information for the quarter and the first year of the 2017-2018 congressional cycle, are now on the NARFE website, <a href="www.narfe.org">www.narfe.org</a>. For example, the reports show our Chapter 1192 contributions for 2017 totaled \$1,725 (\$462 from chapter meetings and \$1,263 from sustainers).

This total placed the chapter 7th out of the state's 21 chapters. With just an additional \$175,

we would have been 5th. So, a little bit can make a big difference! Also to note, the chapter tied for 1st place for the number of sustainers. Both the Bremerton chapter and our Tri-Cities chapter

had 6 sustainers. I'm hoping we can increase this number in 2018!

The state's total PAC contribution for 2017 was \$17,905. Countrywide, the total was \$874,417.44.

The quarterly reports also contain the amount distributed to elected officials during 2017. For our Washington State officials: Suzan DelBene (D-01) received \$2,000; Dan Newhouse (R-04), \$2,000; Derek Kilmer (D-05), \$5,000; Pramila Jayapal (D-07), \$1,000; Dave Reichert (R-08), \$1,000 (funds disbursed before he announced his retirement); and, Denny Heck (D-10), \$2,000. The \$5,000 Congressman Kilmer received reflects his strong support of NARFE issues. He was one of only 17 officials who received \$5,000, or more. (Total an official can receive during the 2-year congressional cycle is \$10,000.)

I want to thank each of you who contributed in 2017, in January and February, and in past years. As Mary Binder wrote in her legislative article, this page, NARFE reported in the February *narfe* that it "thwarted ALL attempts by Congress to cut the earned pay and benefits of federal employees and retirees." The work of NARFE's legislative staff and NARFE members, including PAC contributions, helped NARFE achieve this success on our behalf. Now, with "mid-term" elections in 2018, I will be discussing PAC at chapter meetings, including encouraging contributions and for members to consider becoming sustainers.

### Alzheimer's Research - Larry Williams

For the 6 months ending December 31, NARFE Region IX federations - Alaska, Idaho, Montana, Oregon and Washington – reported donations totaling \$13,959 for the NARFE Alzheimer's Research Fund. Washington State's share was \$5,746.58, of which \$2,720 was from our Tri-Cities chapter. Thank you to all who contributed.



As of the same reporting period, NARFE had raised more than \$12.5 million for Alzheimer's research since the program began in 1986. NARFE's current goal is \$13 million by the end of this year.

### Membership Chairman - Johanna Caylor

The following NARFE membership summary information was in the January NARFE Insider. The 2017 closeout membership number was 208,825. Membership increased from the previous month in each of the last 3 months of 2017.

NARFE closed out the year with 6,935 fewer members than December 2016. (This compares to losses of 17,028 in 2014, 11,332 in 2015 and 9,798 in 2016.)

The number of new members in 2017 was 13,060. (This compares to 9,922 in 2015 and 10,126 in 2016.) This shows positive impact of the Federal Benefits Institute and optional chapter membership.



On-Demand WEBINARS, WHITE PAPERS and RESOURCES for NARFE MEMBERS

NARFE had 26.561 non-renewals in 2017 and reinstated 12,976 or 49 percent (up from the 46 percent reinstatement rate in 2016.)

At the end of December 38.6 percent of memberships are national members and 61.4 percent have continued their chapter membership.

Eight federations increased membership for 2017.

[One of our Region IX federations, Idaho, was one of the 8!] In addition, 6 other federations lost 20 members or less for the year. (Editor's note: Membership Chairman Johanna has been "snowbirding." Look for chapter membership information in future newsletters.)
