Legislative - Mary Binder

Jason Mercier, director, Center for Government Reform, Washington Policy Center, updated members at the February chapter meeting POLICY CENTER Improving lives through market solutions on what is happening in

Olympia during this legislative session. His presentation slides are available under "Programs" on our chapter website, www.narfell92.org. This is a short, 60-day session, scheduled to end March 10.

NARFE's lanuary/February NARFE Magazine action alert asked members to "... use NARFE's Legislative Action Center, located at www.narfe.org, to send a personalized message to your representative urging him or her to cosponsor the Equal COLA Act (H.R. 304)." As explained in the alert, "Current law unfairly reduces FERS COLAs and fails to protect the earned value of FERS annuities." To date, only Reps. Derek Kilmer (D-06) and Adam Smith (D-09) of Washington's 10 representatives have co-sponsored the bill. Please contact Rep. Dan Newhouse, (R-04), our representative, about co-sponsoring this bill.

NARFE is also closely watching the legislature's "continuing resolutions," which NARFE President

Ken Thomas wrote recently "are disruptive" to federal agencies, and the Postal Reform Act of 2022, which it now supports after it was amended to address NARFE concerns, particularly unintended increases to FEHB program premiums for federal employees and retirees.

NARFE-PAC – John Wetterling The 4th quarter

PAC reports for the 2021/2022 cycle ending December 31 are now on



the NARFE website, www.narfe.org. They reflect: the number of contributors; contributions by chapters, federations, regions; and disbursements to candidates, noncandidate committees and leadership PACs. The good news is members are still making contributions, and at a slightly higher average amount, and disbursements are being made. Worrisome news is overall contributions, number of contributors and, consequently, the amount distributed are down from the equivalent period in the 2019/2020 cycle. The primary reason is the drop in NARFE membership. For example, for the same period in the 2019/2020 cycle, our Chapter 1192 had 31 contributors. For the 2021/2022 cycle, we were down to only 18 contributors – a significant drop!

March is NARFE-PAC month – a great time to make a contribution, a special contribution, or become a sustainer. Watch for details in the March NARFE Magazine. I am hoping for improved figures for the 5th quarter!

"NARFE-PAC established ambitious goals for the 2021/2022 cycle," wrote Seth Ikes, NARFE-PAC political associate, in his January PAC letter. Here is a summary of the progress:

- Raise \$1,850,000: **\$902,343**
- Disburse \$1,350,000 for political cotributions: \$559,500
- Send NARFE members to 120 local fundraisers: 52.
