chapter meetings, or call me! Join us for a fun event! (continued on page 2)



Bylaws updates! As this newsletter was finalized, the April 23 special virtual Washington State Federation (WSF) Advisory Committee meeting was approaching.

All WSF members were invited. The primary purpose for the meeting was to approve/disapprove the updated draft federation bylaws. As no comments were received from members during the comment period, it was anticipated



the bylaws would pass. Next step – send them to NARFE headquarters for approval.

Once NARFE approves the WSF bylaws, Chapter President Nancy and I will move forward with updating those for our chapter, which were last updated in 2018. They are on the chapter's website, www.narfel192.org, under "Chapter News" and are a good overview of how our chapter is structured! NARFE FEDERAL BENEFITS INSTITUTE

The NARFE Federal Benefits Institute webinars continue to be a great source for important information, and are FREE for members. For example, the recent "Postal Health Benefits Program: What You Need to Know" was very informative, and is archived on the NARFE website. The new Postal Service Health Benefits (PSHB) program will affect all current and retired U.S. Postal Service employees effective January 1, 2025. As a result, we are experiencing an increase in queries, from both current and retired postal workers. While there are still unknowns about the program, information is being released, e.g., from OPM, NARFE, the Postal Service. We are continuing to monitor the information for impact to our chapter members.

Also, for 6 months, starting April I, "Eligible postal

annuitants and family members not enrolled in Medicare Part B as of January I, 2024 will be eligible for a sixmonth, penalty free, Special Enrollment Period (SEP) to enroll in Medicare Part B." While enrollment is NOT required, "those who take advantage of this SEP will not have to pay the late enrollment penalty, which increases premiums by 10 percent for each 12-month period they could have been enrolled in Part B but did not sign up."

However, here is a recap of what NARFE-PAC does. It "protects NARFE members' pay and benefits by raising and spending money to elect members of Congress who support the federal community ... NARFE-PAC is financed through NARFE members' direct, voluntary contributions to a separate fund." Only NARFE members and "immediate family of these individuals" can contribute. Dues money is NOT used. Questions? Please ask!

At the April Senior Times Expo, I had a chance to visit

with 2 staff members for Congressman Dan Newhouse – Dallas Parr, district representative, Richland office (left in photo) and Vicki Hollerman-Perez, senior district representative, from the Yakima office (right in photo). This was not our first meeting as we



have met and talked at previous Expos and other outreach events. These interactions help us/NARFE maintain visibility with Congressman Newhouse and his staff, both in the state and in D.C.

NARFE's "May Action Alert" remains a focus on the Social Security Fairness Act, H.R. 82. As written, this bill would repeal "the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO)." While WEP and GPO do not affect all NARFE members, they do affect many. See page 8, May NARFE Magazine, for more details. NARFE has been working for many, MANY years to have these bills repealed. While closer than ever to success, we are still not there. Contacting elected officials is critical!
