# NARFE Chapter 1192 October 6, 2010 Chapter Meeting Minutes

<u>CALL TO ORDER</u> President Gary Hagedorn called the Chapter's regular monthly meeting to order at noon, Red Lion Hotel, Kennewick, Wash., welcomed the 31 attendees and led the Pledge of Allegiance. He introduced the head table and new members Helen Brownell and Carole McGraw introduced themselves. Helen is a current Federal employee with EPA and Carole is transferring her membership from Montana. Mel Wicks also introduced himself – he's been a member but not been at a meeting for awhile.

<u>MEETING MINUTES</u> Secretary Mary Binder highlighted the September Chapter meeting minutes. There were no comments or corrections. The minutes were approved. (Note: Both Chapter board and monthly meeting minutes are posted on the Chapter's website, and copies are available at Chapter meetings.)

**TREASURER'S REPORT** President Gary highlighted Treasurer Nancy Crosby's treasurer's report for the period ending September 30. Balance on hand as of August 31, \$6,957.50. September receipts were \$510.04 and disbursements, \$372.13, leaving a balance of \$7,095.41. Projected dedicated funds are \$1,208.00, leaving an undedicated funds balance of \$5,887.41. The Chapter also received \$336.72 from the Federation in per capita tax refund.

<u>Monies collected at the October meeting</u> Luncheon, \$351 (27 paid lunches, \$13/each; 2 members did not have lunch; 2 comps); Alzheimer's Research Fund, \$29; NARFE-PAC, \$20; Newsletter Fund, \$13; and 50/50 Raffle, \$32 collected/ \$16 awarded (and donated to Alzheimer's Research Fund).

## OFFICER/DISTRICT/COMMITTEE REPORTS

<u>President</u> Gary said copies of a chart, *Non-Postal Premium Rates for the Federal Employees Health Benefits Program*, for 2011 were on each table.

1<sup>st</sup> Vice President Don Binder. No report.

**2<sup>nd</sup> Vice President** President Gary announced that 2<sup>nd</sup> Vice President Carl Gallion's hip "re-surgery" was scheduled for Thursday, Oct. 7.

**District V Vice President** Steve Anderson. No report.

<u>Alzheimer's</u> Chairman Bill Darke reported the Chapter's Alzheimer's fund balance was \$140.95. He also reminded members about the Chapter's annual November white elephant auction. Proceeds go to NARFE's Alzheimer's Research Fund.

Hospitality Chairman Carl Gallion. No report.

**Legislative** Co-chairman Don Binder:

- Reminded members to vote in the upcoming elections, but also to study issues prior to voting.
- Again reported there would be no COLA in 2011; however, health benefits costs were rising so there would be less "take home."

**Membership** Chairman Johanna Caylor reported:

- Membership dues are going up in 2011, effective on a member's NARFE membership anniversary date.
- That for retired members, using dues withholding means a 15% reduction in dues (\$34 vs. \$40); she can assist members with this process if they have questions. (Option not available for active employees.)
- NARFE life membership dues are being re-calculated; dues can be paid in 4 payments.
- Many active employees are dropping their memberships after a year. Johanna asked members knowing any such individuals to remind them of the importance of renewing their memberships.
- The Chapter will have tables at the October 14 area health fairs: Social Security Office, Kennewick, 8:00 9:00 a.m., Federal Building, Richland, 10:00 11:30 a.m., DOE Stevens Center, Richland, 1:00 2:30 p.m.

## NARFE-PAC Chairman Don Binder announced:

- There had been much PAC activity with the November elections. On the eastern side of the state, the only request for PAC funds has been from Rep. Doc Hastings. To date, NARFE has not contributed to his campaign.
- PAC contributions are always most welcome and he does have PAC pins for contributions of at least \$20. **Newsletter** Chairman Johanna Caylor. No report. [Note: The Chapter's November/December newsletter is scheduled for distribution in late October.]
