Meanwhile, we still have a large number of issues facing our members. It is important that you keep checking our Chapter website for updates on current events. I also encourage each of you, if you have not already done so, to sign up for NARFE's "GEMS" notifications. For example, NARFE sends out press releases with the latest Congressional information as it occurs. To sign up, go to <http://www.narfe.org/home/>, the NARFE website, click on "Members," and enter your membership number and last name. The menu on the left side has a category, "What You Can Do Online." Click on "Join GEMS." That will bring up a page that asks for your membership number and date of birth. Then, click on "submit."

Next, we will be voting on NARFE's Dues Referendum at our November 4 meeting. Our chapter is allotted 8 votes and they can be split pro and con. **On page 3, this newsletter, there is a ballot you can submit to me if you will not be able to attend the meeting so your vote will be included.** On our website, there is an overview of the new dues structure and the effect on our chapter dues. Please check it out.

There will be changes in the FEHBP for the coming year. Please ensure you read your latest NARFE magazine and look for information in the mail from OPM. View the premium costs at: <http://www.opm.gov/insure/health/rates/index.asp>. Click on the appropriate program, e.g., HMOs, pages 40-41; Fee for Service rates, pages 1-2. Also, we were represented at the FEHBP Health Fair, October 15, Federal Building, Richland, and the Stevens Center. Many insurance providers had representatives there with information on their programs. We will have a limited supply of brochures at the Chapter's November meeting.

The WSFC is seeking volunteers to serve on committees: Convention and Special. Our Federation leadership wants to maintain these committees year round. I will bring the sign-up forms to the November meeting. And, if you are interested in running for a state office, I am on the nominating committee and can provide the requirements for submitting an application.

## Legislative – Don and Mary Binder

As we're sure you know, it has been a busy time for our legislators, with much media coverage, and at times, confusion for many of us trying to sort through issues. We continue to monitor what is happening, especially focusing on issues having the potential to affect NARFE members and their benefits. As others have written, a good place to get updated NARFE information is the Chapter's website. And, as we recommend in each newsletter, contacting our legislators and telling them what we think remains most important. Contact information is listed below. Now, to report a "good-news" story ...

One of NARFE's recent legislative initiatives deals with active Federal employees covered under the Federal Employees Retirement System (FERS) and the ability of those employees to have their unused sick leave credited when they retire, as is currently allowed for those covered under the Civil Service Retirement System (CSRS). The provision was approved by both houses of Congress, is in the 2010 Defense Authorization bill, and, by the time you read this, the President will most likely have signed it into law. It provides for a 4-year phase-in period. Until December 31, 2013, employees would receive 50-percent credit for unused sick leave; they would receive full credit beginning January 1, 2014.

## NARFE-PAC – Don Binder

NARFE-PAC is NARFE's legislative arm and allows it to provide a high-quality office to work with Congress, through elected members and staff, to ensure NARFE issues are "front and center." One example – contributions of up to \$5,000 to those running for re-election or against an incumbent when there is a clear difference between the candidates, and one clearly backs NARFE legislative initiatives and the other does not. Additionally, the one who does would use the NARFE contribution to "provide the last dollars for the last vote to win." **For another example of how funds can help, see the "legislative" update, this page.**

The current "election cycle" is January 1, 2009 through December 31, 2010. As of September 30, nationally, NARFE members had contributed \$127,425.51. Our Chapter 1192 had 12 members give \$475.00. 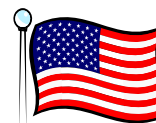
**Help:** NARFE not only needs new members – we need to **retain** the members we have. Help our Chapter and NARFE grow and sustain strength!
