At the August NARFE national convention, there were significant discussions about "Future NARFE." To further pursue this initiative, members voted to have a strategic planning committee established not later than February 1. Stay tuned!



By more than 80% approval, members also voted to eliminate 2 national officer positions – vice president and secretary – leaving just a president and new secretary/treasurer positions. They elected current treasurer, Dick Thissen, president, and Jon Dowie, secretary/treasurer.

Our Region IX vice-president, Lanny Ross, ran unopposed for what he insists will be his last 2-year term. We are grateful he has agreed to continue serving as our representative. He is now the longest-serving member on the NARFE National Executive Board.

Last year by a unanimous vote at our September chapter meeting, members approved changes to our chapter bylaws. Included in the changes – all elected positions would be for 2-year vs. 1-year terms. Therefore, no elections this fall as all current elected officers are completing their first year of the new 2-year term.

Long-time chapter and federation leader, Carl Gallion, has resigned as our hospitality chairman. While Carl is still very much a Chapter 1192 member, he did not believe he could continue to perform the required duties. Carl, we cannot thank you enough for all the years of incredible service in numerous chapter leadership positions, including president, and as our federation district vice president.

Also resigning, our long-time parliamentarian, Mable Rutt, due to a health issue. As with Carl, we will miss her in the chapter leadership, appreciate her continued membership and wish her all the best.

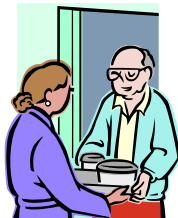

But, the OPM website has much more information about the different health benefits options available. Per OPM, on average, federal employees' healthcare premiums will rise 3.2 percent in 2015.

Legislative – Don and Mary Binder

As we write this article, we have received our ballots for the November 4 election. For all our chapter members in Washington State, you also should have received yours. For our members who go to a polling place, we face the same hard decisions – who to vote for this year for our members of Congress. They'll be taking their oath January 3.



For chapter members living outside Washington's 4th Congressional District, we strongly suggest you review the voting record of the incumbent House and Senate members, pages 30-40, October *narfe* magazine. If like those of us in the 4th district you have an open seat, study issue papers, websites, news articles and, if possible, attend debates or other venues to hear the candidates, all of which should aid you in reaching a conclusion regarding who should earn your vote.

While there are many issues still very much on the radar of various members of Congress, e.g., postal reform, we still believe the only potential cause for concern is when Congress debates what we expect to be a "continuing resolution." President Obama signed the existing one that funds the federal government through December 11. Thus, some action will need to be taken during the "lame-duck" session of Congress that begins November 12. Various members have differing views, but know the NARFE headquarters legislative staff and the 2 of us will continue to pay particular attention to any issues that could potentially have a negative impact on current and retired federal employees.



So, bottom line, exercise your right as a citizen and VOTE!

There are several good reasons to donate to NARFE's PAC. Six are listed in the newly update NARFE-PAC toolkit:

- Donations help achieve NARFE's legislative goals.
- All contributions are individual and voluntary.
- Contributions help provide clout to NARFE's political activities, i.e., a means by which individuals can, in some way, have an influence on important congressional elections in states other than where they live.
- May help gain congressional support for issues important to NARFE when such support may help elected officials retain their seats.
- PAC contributions often coincide with candidate fundraisers in districts, states or in D.C. These interactions promote networking and aid in future lobbying and grassroots actions.
