For quick reference, the mission statement is in each *narfe* magazine along with the president's message. It has the guiding principles for how NARFE operates. Recommendations for future changes to NARFE's organizational structure and function must adhere to these principles.

## STRATEGIC PLANNING

We are fortunate to have full-time professional staff close to the action in Washington, D.C., and who have our best interests in mind. I think they do a good job keeping us informed through the *narfe*, the NARFE national website and email updates. We do, however, have responsibility as members to pay attention to the information and to act upon it, when necessary.

Another part of our mission statement speaks to involvement with "other organizations and associations" to promote our objectives. In my mind, this is a particularly important point. Anything that can be done to demonstrate the utility and effectiveness of the federal workforce, and the contributions of its retirees, is a worthwhile endeavor, especially given the often negative slant on news coverage. #### Legislative - Mary Binder

So, where to begin and what to focus on? There is SO MUCH happening that it is mindboggling, right? Whether it's the presidential-candidate debates, continuing resolutions to keep the government operational, the federal budget, watching the scenario unfold regarding a new speaker of the House, no COLA for 2016 or an increase in health benefits costs, our news days are full! While all of these are important, or at least interesting, I'm opting to focus one issue of prime importance to many NARFE members – the potential 52 percent increase in the Part B Medicare premium. Why might this happen? 7192

NARFE President Richard Thissen provided the following information in the October 15 Legislative News email. The "hold harmless" provision in the Social Security Act states that the dollar increase in the Part B premium is limited to the dollar increase in an individual's Social Security benefit. With no COLA in 2016, an estimated 70 percent of beneficiaries will be held harmless, meaning, for most, their Part B premium will remain at \$104.90. This leaves 30 percent of beneficiaries, including CSRS retirees who do not receive Social Security benefits, to shoulder the full cost of the 2016 premium increase, resulting in a projected premium increase of 52 percent, from \$104.90 to \$159.30 per month. And if that wasn't bad enough, FEHBP premiums also are increasing more than 7 percent.

NARFE's legislative staff is monitoring this closely and working with congressional staff members. While legislation has been introduced to "guarantee that **all** Medicare beneficiaries pay the same Part B premiums in 2016 that they paid in 2015 (H.R. 3696 and S. 2148), NARFE is asking members for their assistance by contacting their elected officials. our responsibility as individual members to help fund NARFE-PAC's efforts on our behalf and to do our part by interacting with our own local congressional staff. If our personal contributions to NARFE-PAC decrease or dry up completely, so does its effectiveness in dealing with issues of importance to us.

#### Alzheimer's Research - William Darke

November is NARFE's Alzheimer's month and our chapter again will be having its annual white elephant fundraiser. This year rather than "auctioning" items, we will sell tickets that can be placed in a bag for each item.

The more tickets you put in a bag, the more chances you have to win that item when the winning ticket is drawn.

So, please bring an item, or more, to donate, plus cash or a check!

This year NARFE had \$479,208.00 available for research projects. Four were selected for funding/partial funding. These will be directed toward answering the following questions:

- ◆ Can aerobic exercise intervention help improve brain structure and function, and reduce the risk for Alzheimer's in individuals with type 2 diabetes.
- Are levels of apolipoprotein E in the blood and cerebrospinal fluid related to the onset, progression and severity of Alzheimer's disease and dementia with Lewy bodies?
- Can the study of exosome activity lead to a novel blood test for Alzheimer's disease.
- Can novel imaging technique that detects damage to the blood-brain barrier be used for early detection of Alzheimer's.

We hope these projects are successful!
