

Speaking of voting and its importance, at the NARFE national convention, delegates voted on a number of resolutions and amendments that would have, or will, mean changes for NARFE. Of major concern to many in our Washington State Federation of Chapters and the other 4 federations in our Region IX - maintaining the current 10-region NARFE structure and inserting that number into the NARFE bylaws. This proposal failed by just 3 votes, although the initial report was by just one vote. Whether 3 votes or just a single vote, think what a difference a single vote, or even just a few votes can make! What a lesson and reinforcement for all of us!! So. please ensure you vote in our upcoming elections. 9324

Another vote at the convention that has the potential to affect all NARFE chapters, including our Chapter 1192 optional chapter membership. Effective immediately, new members will have the option of just joining NARFE and not having to join a chapter. There is no longer a NARFE "e-chapter." #### **Director at Large - Steve Howes**

A number of factors at the NARFE national, state and local levels are making it necessary for our chapter to make some important decisions regarding our future. As you are aware, NARFE membership at all levels is declining. This trend needs to reverse if NARFE is to remain a viable and effective organization.

At the recent national convention, delegates voted to make chapter membership optional and to change NARFE's voting to one member, one vote, regardless of chapter affiliation. When new members join NARFE, they will have the option of just joining without joining a chapter. Renewing members can also make the same decision, that is, to remain in a chapter or to opt out of chapter membership. As you can see, this has the potential to make it even more challenging for local chapters to recruit and retain new members.

Locally, our Chapter 1192 has a devoted core group of members. However, those who attend regular monthly meetings are almost exclusively retired federal employees. Having luncheon meetings makes it difficult for active federal employees to attend. Further, despite little input from chapter members and/or offers to arrange for a presentation or speaker, the chapter's executive board continues to work to come up with interesting meeting programs. And with the end of the calendar year approaching, we will be asked if we wish to continue our working arrangement with the Columbia Center Red Lion and/or continue with business as usual.

Considering the above, I think we need to ask ourselves a few important questions:

Are we really serious about attracting new members including those who may be current federal employees? If so, this might require changing meeting times, format and location, at least for some meetings. We have recruited a number of new members over the past few years; but, how many have come to meetings and continued their memberships?


Do we want to continue primarily as a social organization or do we want to focus our meetings solely on issues important to retired and active federal employees? Many of our meetings deal with topics unrelated to NARFE's stated mission. That is certainly fine, but should the focus be more mission oriented?

There are a number of options we could consider to address the above questions:

- Reduce the number of meetings (e.g., eliminate the June and September meetings; have quarterly meetings).
- Schedule a combination of day and evening meetings.
  This may help to attract active federal employees.
- Schedule a combination of social and mission-oriented meetings (e.g., potlucks or other events that encourage attendance by potential new and/or current members and their families; encourage district and federation officers to attend our meetings and focus on issues important to NARFE). 6458

These are only a few of several options that could be considered. In any event, some changes will be needed in the future. Your executive board does not want to make

any important decisions without input from chapter members. If you have any comments or suggestions regarding how we as a chapter should move forward, please write them down and submit them to one of the board members or

go? NARFE has reports on its website available to members! To access the reports: 1) Log onto the NARFE website as a



member; 2) On the homepage, go to Departments; 3) Click on "Legislation;" 4) Scroll down to the middle of the page and click on the "NARFE-PAC" link; 5) On the NARFE-PAC homepage, click at "Quarterly Reports" at the bottom. There you will find both contribution and disbursement reports. Contribution reports include data by regions, states and chapters. Disbursement reports are by states. Besides reports for the current congressional cycle, there are reports for 2011-2012 and 2013-2014.

#### WSFC President - Nancy Crosby

I will become the Washington State Federation of Chapters president, November 1. Please know, I will do my best to represent you and our federation.

Rich Wilson, former WSFC president, was elected at the national convention to be the Region IX vice president. Lanny Ross, who has served as the region's VP for 16 years, opted to not run again. Therefore, according to our federation bylaws, the vice president moves into the president's position.

The federation held its quarterly board meeting at the Tri-City Country Club, Kennewick, September 21-22. Other position changes include: Karol Kusunose (Tacoma chapter) was appointed as the new vice president; Mary Binder (Tri-Cities chapter) will be the new District V vice president; Lorie Bennett (Tri-Cities chapter) will be the new federation Alzheimer's chairman; and, Sam Cagle (Olympia/Timberland chapter) is the new federation NARFE-PAC coordinator.

In her article, page I, Lorie encouraged all members to vote. I want to also encourage you to vote. It is our opportunity to cast our votes for a new U.S. president; one of our U.S. senators; our representative to the House; 9 state positions, including a governor; local officials; and numerous initiatives. Voting is an opportunity for all of us to express our views.

Staying with voting – delegates at the recent national convention voted on resolutions and amendments to NARFE's bylaws that will require bylaws changes. As NARFE President Richard Thissen emphasized, the changes involve not only the bylaws but a thorough review of many NARFE documents. The 2016 bylaws are projected to be finalized and publicized sometime in early 2017. Once those have been published, our federation bylaws will also need changing, and I expect most chapter bylaws will also need modifying. So, work ahead, and it's not too soon to get started!

Also looking ahead, the federation board approved a

\$250 scholarship for all federation members attending the biennial NARFE Legislative Training Conference in Alexandria, Va., March 12-15. Registration opened October 1; information is on the NARFE website. At this point, the



Tri-Cities chapter will have at least 3 members attending.

Finally, looking even further ahead, Region IX will hold a joint Leadership Training Conference at the Three Rivers

Convention Center, Kennewick, June 9-10. The Alaska and Idaho federations will chair the event with support from the Montana, Oregon and Washington federations. More information soon, but mark your calendars now!

## Legislative - Mary Binder

As this newsletter is finalized, so is this election season, for all practical purposes. So, what's next with Congress in session November 14 for most likely just a short time?

The "continuing resolution" passed on September 29 to keep the government funded at current levels expires December 9. Will there be another "CR?" Stay tuned.

Will there be a fix for those "not held harmless" by the Social Security law that would save them from a significant increase in Medicare Part B premiums? NARFE's Legislative Action Center has a letter on this issue to send to our elected officials. Again, stay tuned.

The November and December narfe magazines have/will have information about the FEHBP plans and important information you need to know in making decisions.

And a state-level initiative that we'll be monitoring - "a city initiative that would levy an income tax on Olympia residents whose household income exceeds \$200,000. Would this be a stepping stone to a statewide income tax? Once again, stay tuned!
