Ensure you are signed up to receive information from the national office.

We have just received the information on our FEHB programs and premiums for 2018. Please review the information closely. Decisions are individual, based on your needs and/or that of your family.

REMEMBER, you must make a decision during **open season, November 13 to December 11**, if you wish to make any changes. For more details,

Your Washington State Federation of Chapters board is working hard to retain our members and support our chapters. 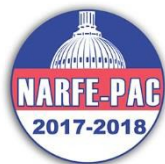
information about our elected officials, easy-to-use ways to contact our elected officials, how to contribute to NARFE-PAC and much, much more.

President Lorie recently wrote, “NARFE [legislative staff] is doing everything it can to protect our pay and benefits. As members we can do our part by contacting our representatives by email or phone.” Maybe a New Year’s resolution if this is something you don’t regularly do?

## NARFE-PAC – Bob Stewart

The third quarter NARFE-PAC reports are now available on the NARFE website, [www.narfe.org](http://www.narfe.org). I’ll provide updates at the November chapter meeting.

NARFE is preparing and advising chapter members to prepare for the 2018 mid-term elections. Candidates are preparing their campaigns. Watch for more details, including PAC fundraising goals.



Federal employees and retirees continue to be targets, whether from the president’s proposed budget and/or proposals in Congress. Examples include:

- ♦ Reducing the government contribution toward federal health insurance.
- ♦ Using the Chained CPI to determine COLAS.
- ♦ Reducing the TSP G Fund rate of return.
- ♦ Increasing federal employee payroll contributions toward retirement by as much as 6 percent.
- ♦ Eliminating the FERS annuity for new hires without an equivalent increase in pay or TSP contribution.
- ♦ Across-the-board federal employee pay freezes.

Clearly, we have our work cut out to prevent or mitigate these proposals from taking effect. Yes, we need to contact our congressional representatives!


