

The annual Federal Employees Health Benefits Program Open Season is upon us. This is the time when federal employees and retirees can enroll, change, suspend or cancel federal benefits coverage for the coming year. OPM announced that the average premium increase is 3.8 percent, primarily due to prescription drug increases. (NARFE President Ken Thomas and the advocacy staff are continuing to urge Congress to work to lower these costs.) Also, OPM will again have the comparison tool available to help you compare plans.

# NARFE FEDERAL BENEFITS INSTITUTE

Further, NARFE has webinars scheduled that may help you. (See list below.) There were 2 in October, "Understanding Medicare Advantage Options" and "Federal Dental and Vision Insurance: FEDVIP Explained," that are archived on the NARFE website under the Federal Benefits Institute tab, along with all other NARFE webinars. Center's Eastern Washington annual dinner October 15, in Spokane. Guest speaker was Dr. Ben Carson, HUD director during the Trump Administration. Congressman

Dan Newhouse and his wife, Joan, were among the attendees. We had an opportunity to personally thank him for his recent cosponsorship of H.R. 82, the Social



Security Fairness Act, which would repeal GPO and WEP – top NARFE legislative priorities for many years.

Thank you to all who sent letters or made calls asking Congressman Newhouse for his support. Our personal stories regarding the impact GPO and WEP have on more than 2.3 million retirees resonated with him. Please continue those contacts as we work toward repeal.

As scheduled, the 2022 COLA was announced in mid October. While 5.9 percent/CSRS and 4.9 percent/FERS increases are the largest in a very long time, much will be offset with healthcare premium and other price increases. For more information on the COLA, go to: www.ssa.gov.
