CHAPTER NATIONAL SYMPOSIUM REPORT (Joe Kuhns-Chapter President)
I would like to mention briefly the two-day Regions VIII and IX Management and Development Symposium conducted at the Peppermill Hotel and Casino by the National Officers September 27-29, 2005, in Reno, Nevada. Over 200 people were in one three seven three attendance including 4 of us from Chapter 1192. The theme was sharing experiences, building relationships, and implementing ideas. The topics were: recruiting and retention, leadership and development, chapter communications, and meetings/activities. Experienced practitioners called “jump starters” led the series of four sessions, three of whom were from the Washington State Federation, with input by many of the participants. It was deemed to be a very successful effort and is planned to be repeated. I would say the primary emphasis was on recruiting and retention, but there were many other topics of equal or greater concern. You may wish to refer to the National Secretary Davis Sullivan's report for more information on page 62 of the October 2005 NARFE Magazine. He was in charge of the four symposiums held across the country in Macon, GA., Harrisburg, PA., Reno, NV, and Denver, CO. I took some rather detailed notes on the proceedings and would be happy to share them with the Chapter Executive Committee or any others who might have an interest in efforts to make changes for possible improvements in the chapter activities and/or operation.

IMPORTANT NEWS FROM NARFE, September 21, 2005

NARFE DEPLORES PLAN TO OFFSET HURRICANE RELIEF BY CUTTING THE EARNED RETIREMENT AND HEALTH BENEFITS OF FEDERAL WORKERS BY \$11.5 BILLION

National Active and Retired Federal Employees Association (NARFE) President Charles L. Fallis today denounced the House Republican Study Committee's (RSC) proposal to reduce the retirement annuities of federal workers and require many of them to pay a higher share of their health insurance premiums.

The RSC's "Operation Offset" paper, released today, suggests that future federal retirees with less than thirty years of service pay a higher percentage share of their Federal Employees Health Benefits Program (FEHBP) premiums than others. The government/employer contribution for FEHBP premiums is 72 percent of a weighted average, and employees and retirees pay the remaining 28 percent. According to the Congressional Budget Office (CBO) estimate of this proposal, "the government's share of premium costs would be cut by 2 percentage points for every year of service less than 30. In the case of a retiree with 20 years of service, for example, the government's contribution would decline from 72 percent of the weighted average premium to 52 percent." Such a retiree would pay about \$2,700 more in 2006 than an employee or retiree with 30 or more years of service if they were enrolled in an FEHBP Blue Cross/Blue Shield standard option family plan.

"Not only would these proposals dishonor the government's obligations to its workers, but it also makes public service a much harder sell to talented and skilled persons in today's mobile workforce," Fallis said. "How ironic is it that this committee would offset Katrina relief by cutting the earned economic and health security of the very federal workers that are laboring to get Gulf Coast businesses and residents back on their feet."

"Most of my generation worked for the same employer for our entire careers, but those days are gone," Fallis observed. "This proposal runs counter to every innovation made in employee compensation in the last 20 years aimed at making benefits portable and enabling workers to move to employers where they are needed the most."

In addition, the RSC paper recommends that the federal civilian annuity calculation be based on the highest five years of salary instead of the highest three years. The CBO estimates that this would result in future Civil Service Retirement System (CSRS) retirees receiving "\$1,400 less in 2006 and \$7,300 less over five years than under current law."

Fallis concluded, "Federal workers and annuitants have dedicated, and continue to give, so much for our nation and our ideals. NARFE urges the Congress not to use this recent natural disaster as an excuse to sully their service by reducing the retirement and health benefits which are rightfully theirs."

NARFE, one of America's oldest and largest associations, was founded in 1921 with the mission of protecting the earned rights and benefits of America's active and retired federal workers. The largest federal employee/ retiree organization, NARFE has a membership of nearly 400,000 men and women and represents the interests of nearly 2.3 million federal employees, retirees, spouses, and survivors.

Lowering the Government's share of the Federal Health Benefits, delaying or canceling COLAs, and recalculating retirement formulas to reduce annuities are all targets against current and future retirees.

Please join us in standing up for our earned benefits. Especially vulnerable are our CFEs who are contributing so greatly by leading the rebuilding efforts after this terrible storm. Call, write, e-mail or FAX your Representative or one of your Senators. Let them know you **do not want our earned benefits denied or changed.** We need your help to get this message to Congress. NARFE-FEEA AID TO VICTIMS OF KATRINA

URGENT NARFE ACTION ALERT ON MEDICAID

(This article was received AFTER the NARFE News, Issue #3 went to Press)

During the next few weeks, Congress will focus on completing action on the federal budget. Known **as budget reconciliation**, this process involves setting spending reductions for entitlement programs such as Medicare, Medicaid, Social Security, federal and military retirement. Currently, there are no plans in this legislation to cut federal civilian retirement. However, this fall's budget reconciliation bill will attempt to reduce spending for health care for the elderly and disabled provided by Medicaid. One of the proposals is to make it harder for people to qualify for *nursing home care under Medicaid* by changing certain rules.

We urge you to contact your Representative and two Senators through a special toll free number at **1-800-426-8073** and ask them "to oppose cuts to the Medicaid budget that would change *nursing home* transfer of assets rules." These changes will harm the elderly and disabled citizens who need this program the most.
