Cooler weather will soon be here and bring relief from our sizzling summer.

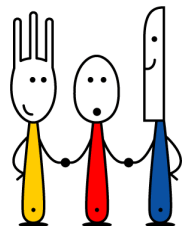

## 2nd VP/Webmaster – Larry Williams

In the summer NARFE Washington State Federation of Chapters (WSFC) *Federation Reporter* newsletter, WSFC Service Officer Charlie Caughlan wrote, "All Medicare cards will be replaced with new numbers by 2019. Currently, the number on Medicare cards is essentially an individual's Social Security Number (SSN). While using that number probably made sense back in 1965 when the program was enacted, in this day and age of computers, using SSNs is not a good idea. It is just too easy for someone to steal an individual's identity with a SSN. The new Medicare numbers will be randomly generated digits and letters to protect against identity theft."

Charlie further stated that with more than 57 million Medicare recipients, it will take time to transition to the new numbering system. When new cards arrive, shred old cards. ***Further, there may be scammers out there, who may sound official, asking for a member's current Medicare number so they can send a new card. Be alert! Be aware!***



## WSFC President – Nancy Crosby

***Membership recruiting and retention MUST BE the focus for our Washington State Federation of Chapters (WSFC) – both at the federation and chapter levels.*** To note, we are in the process of closing 2 state chapters for lack of leadership and chapter support. Even though these chapters have more than 250 members each, they cannot get

members to step up and fill the necessary leadership positions for a successful, healthy chapter. This is a great loss to our federation and to the members who depend on their chapters to keep them informed on the issues affecting their earned benefits. So, when your chapter calls on you to run for an elected office, volunteer for a committee or become more involved, please step up. Preserving our chapters is vital to NARFE's success.

From September 1 through December 31, NARFE is offering a \$10 rebate to recruiters for each new member they recruit. Also, our WSFC gives a chapter a \$20 rebate for each new chapter paid membership in 2017.

The NARFE membership and renewal forms are being updated at the insistence of the federation presidents at their July meeting in Jacksonville, Fla. The revised forms will focus more on chapter memberships. Many new and renewing members have been inadvertently joining or renewing at the "national-only" level not realizing there is a local chapter option or, for renewing members, that they dropped their chapter membership.

August was NARFE Grassroots Advocacy Month. Many chapter members in our federation attended town halls, had visits with their representatives, etc., and now will continue to work on building positive relationships with their congressional contacts. Even though this is not an election year, it is imperative that we are involved in learning about our congressional candidates. # Mark Your Calendar

## Legislative – Mary Binder

In a recent NARFE Legislative Department electronic “Advocacy Alert” email, there was a reference to NARFE’s “Three Top Legislative Priorities.” They are: prevent harmful budget proposals; modify postal reform legislation (H.R. 756); and, support the TSP Modernization Act (S. 873/H.R. 3031). Copies of the “issue brief” with key points will be available at the September 6 chapter meeting. If you cannot attend and want a copy, please contact me.

The same alert message contained good information for all of us when either meeting, or writing to, our elected officials about an issue. To note, “In congressional meetings, your role as a NARFE member is to humanize an issue and help your legislator understand the impact policy changes would have on their constituents. You have a unique opportunity to be a catalyst for change if you structure your messaging around the issue in a personal and memorable way.”



So, how to do this? The Legislative Department staff wrote that, “A successful story is easy to remember, simple to articulate, and reduced to the core elements of NARFE’s mission. If your story is simple it will be more memorable, and if you lay out the key reasons that you opposed or support the legislation at hand, you will have a compelling perspective for the legislator to consider when deciding whether to support or oppose the legislation you discussed.

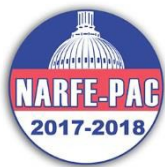
