The referendum is an attempt to simplify NARFE's complex and multi-tiered dues structure. It is believed that such simplification will help in everything from recruiting to a treasurer's duties. But as with many things, there are pros and cons to a unified dues structure.

The referendum calls for \$40 yearly membership dues for regular members. In your August *NARFE* magazine, pages 43-44, there is more information, including a sample ballot and information on the voting process. We, as a chapter, will vote on this referendum. Please read the information on the referendum carefully, and plan on attending our monthly meetings for discussions and updates.

In October we plan to invite an officer from the Washington State Federation of Chapters (WSFC) to give us more insights on this proposal from a federation perspective. #### Legislative – Don and Mary Binder

Due to the recession we as a nation are still confronting, it appears all but certain that there will be <u>no</u> Cost of Living Adjustment (COLA) for either Social Security or Federal employee retirement benefits this coming January. However, under current law, even though the COLA has been reduced, our retirement annuity will not be.

Next, although the figures have not yet been released for 2010, it appears likely that our health benefit costs will increase, thus resulting in a reduced "take-home" or net payment each month starting in February.

Please continue to follow the discussion regarding health insurance being debated by the Obama Administration, members of Congress and print and broadcast media. While we, as current, retired or spouses of Federal retirees, have one of the best health insurance programs in the country, the pending legislation could impact on us. Our congressman, "Doc" Hastings, is opposed to the legislation presently before Congress, but already approved by 3 different House committees. Letting him, and our senators, Patty Murray and Maria Cantwell, know your feelings in this regard, helps give you a voice in this critical debate. As you may know, the voluntary contributions to the NARFE-PAC are used to provide funds to people seeking election to Congress, either an incumbent or someone running for that office, who support the legislative issues important to NARFE members.

To date, since the start of this cycle for contributions, only 8 members of our chapter have contributed to NARFE-PAC. While the total is a very generous amount, \$395, other members need to consider what NARFE-PAC does for you. Besides contributions to those 3208 seeking Congressional office, it also provides funds to permit headquarters staff to work on NARFE's legislative goals – to maintain our existing benefits and work toward repeal of GPO and WEP.
