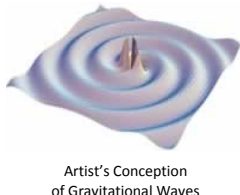

If ever there was a time to have a strong PAC to represent NARFE, it’s NOW! Washington State NARFE members contributed more than \$33,000 for the 18-month period ending June 30 and beginning January 2011 for the 2011/2012 Congress. Chapter 1192 contributed almost \$2,000 during that time period. This is good, but I know we can do even better. For example, an automatic monthly commitment of \$10 will make you a “sustainer.” Contact me for details, or just to make a contribution. Remember, every dollar helps strengthen our NARFE voice!

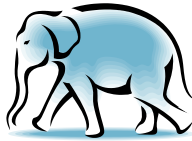


To help members in their decision-making process for the November 6 general election NARFE has calculated some “voting” figures for incumbents in Congress on NARFE initiatives and has them on the NARFE web site, www.narfe.org. Examples: since 2003, our Tri-Cities area representative “Doc” Hastings has voted on 23 of 25 NARFE initiatives and voted “for” on 6 of those, equating to a 26% NARFE voting record; our U.S. senator, Maria Cantwell, is 14 for 14, equating to a 100% record. Again, another tool for NARFE members in making informed decisions for the November 6 general election. If you have questions, please feel free to contact me.

Alzheimer's Research – William Darke

Looking back – total donation numbers for the Fiscal Year 2012 NARFE Alzheimer's Research Fund, July 1, 2011 through June 30, 2012, have been tabulated. How did we do? Nationally, the fund received **\$557,839.17**. Our Washington State Federation contributed **\$11,038.82**, of which our Chapter 1192 contributed **\$1,455.37**! NARFE is now very close to its \$10M goal! Thanks to everyone who contributed. It just goes to show what a difference we can make when we all work together.

Looking ahead – Chapter 1192's annual "white elephant" Alzheimer's fundraiser auction will be at the November 7 meeting. So, time to start thinking about that item or items you want to donate for the auction!
