

Updating bylaws! Yes, it is again that time – for the Washington State Federation (WSF) and our chapter.

For several weeks, in my position as the WSF Eastern Washington VP, I worked with my



counterpart for Western Washington, VP Bea Bull, on reviewing and updating the WSF bylaws, They were last updated in 2018. The WSF Advisory Committee approved the draft revision at a January meeting, and they are now available for all WSF chapter and national-only members to review on the new WSF website. www.narfe.org/wa/. Service Officer (Acting) - Nancy Crosby

As I wrote in my president's article, page I, this will be a busy year. An example – the new Postal Service Health Benefits (PSHB) program. With implementation scheduled for January I, 2025, we are seeing an increase in queries, from both current and retired postal workers. At this time, there are still unknowns about the program, including which healthcare providers will be offering coverage in the new program.
